BYLAW ONE: Article XIII. Philanthropy and Community Service, Section 2, E

- ORIGINAL

- Alternative Breaks

- Individuals who participate in Alternative Breaks shall receive 5 of the 10 community service hours, required by the Community Standards program, for participating in Alternative Breaks, even though they may have not taken place in Douglas County or have been completed during an academic semester.

- REVISION

- Alternative Breaks

- Individuals who participate in Alternative Breaks shall receive 5 of the 10 community service hours, required by the Community Standards program, for participating in Alternative Breaks, even though they may not have taken place in Douglas County or been completed during an academic semester. **Any community service hours completed during winter or summer break will count towards the following academic semester.**

- **Service Trips**

- **Individuals who participate in Service Trips shall receive 5 of the 10 community service hours, required by the Community Standards program, for participating in Service Trips, even though they may not have taken place in Douglas County or been completed during an academic semester. Any approved community service hours completed during winter or summer break will count towards the following academic semester.**
- **A permission request form must be submitted to be approved by the Director of Philanthropy and Community Service two weeks prior.**

- REASONING

- We feel it is important that women who choose to do a service trip outside of Douglas County are able to be recognized for their cause. Because of this, we have added a sentence under Alternative Breaks that allows women to get credit over academic breaks. We have added a section titled "Service Trips" to expand beyond Alternative Breaks. These trips need to be approved by the Director of Philanthropy and Community Service chair two weeks prior.

BYLAW TWO: Article VIII. Committees, Section 3

- ORIGINAL

- The Judicial Board shall consist of the Director of Judicial Affairs as Chief Justice and five members.
- REVISION
 - The Judicial Board shall consist of the Director of Judicial Affairs as Chief Justice **and a designated number of Judicial Board members the Director of Judicial Affairs feels suitable for their term.**
- REASONING
 - This will allow each new Director of Judicial Affairs to reasonably fill the board as they see fit without needing to pass new bylaws (like I am) each year. Since there can only be one member on the board from each chapter, this would mean this year there would be max 11 members (plus me) and min 3 members per NPC bylaws. This also allows the Director of Judicial Affairs to not feel obligated to take a specific number if they feel they do not have that qualified number.
