E. Any person fitting the definition of a non-member must be placed on a guest list and designated as a non-member. A copy of the guest list ~~(with the names alphabetized)~~ must be turned in 48 hours prior to the event of function. This is for events for both councils

a. Failure to turn in the guest list within the appropriate timeframe will result in the following fines

i. For the first infraction of the semester:

A chapter will be fined \$50 for any guest list submitted after the 48 hour deadline.

ii. For the second infraction of the semester:

A chapter will be fined \$75 for any guest list submitted after the 48 hour deadline.

iii. For the third infraction of the semester:

A chapter will be fined \$100 for any guest list submitted after the 48 hour deadline. It will also result in an appearance before the Judicial Board.

b. Late, missing or incorrect guest lists will result in the Director of Health and Safety notifying the Judicial Board.
